ONE PRODUCTION ONLY (OPO) LETTER OF ADHERENCE to the 2009-2012 St. Louis Local Code of Fair Practice, 2009 AFTRA Radio Recorded Commercials Contract, 2009 AFTRA Television Recorded Commercials Contract

The undersigned wishes to enjoy peaceful and pleasant relations with the American Federation of Television and Radio Artists (AFTRA) and, to that end, the undersigned agrees as follows:

By signing this Letter of Adherence, the undersigned agrees to be bound to 2009-2012 St. Louis Local Code of Fair Practice (hereinafter referred to as the "Local Code"), and to the 2009 AFTRA Radio and Television Recorded Commercials Contracts. By delivery to AFTRA of this signed Letter of Adherence, the undersigned shall be deemed to have executed and agreed to each of the agreements referenced above only with regard to the one production referenced below. The undersigned represents that it has received a copy of each of the agreements referenced above and has read and is familiar with all terms and conditions of said agreements.

It is expressly understood that production under this Letter of Adherence to 2009-2012 St. Louis Local Code of Fair Practice is limited to television and radio commercials which fall under the provisions of 1. GEOGRAPHICAL JURISDICTION A, Paragraph 1 (see page 12 of the local code for map of Local ADI). The territory of said area shall be referred to as "The Local". It is understood and agreed that the undersigned is bound to the 2009 AFTRA Radio and Television Recorded Commercials Contracts in the event the applicable production airs beyond the Local. Without limiting the generality of the foregoing, the undersigned agrees to all arbitration provisions of the 2009 AFTRA Radio Recorded Commercials Contract and the 2009 AFTRA Television Recorded Commercials Contract. **AFTRA may, at its option, reopen contract negotiations on October 1, 2010 by giving 30-days notice, to discuss an increase to AFTRA scale minimums only.**

Further, the undersigned agrees to all the health and retirement provisions of the 2009-2012 St. Louis Local Code of Fair Practice and to be bound by the AFTRA Health and Retirement Funds Agreement and Declaration of Trust, dated November 16, 1954, as thereafter amended, and to abide by and conform to all of the terms and conditions specified in the aforementioned Trust Agreement, including amendments thereto; and, more specifically, the undersigned hereby appoints the Producer Trustees named therein and/or their successors.

AFTRA reserves the right to review this Agreement to determine if the undersigned is a bona fide Producer of Recorded Commercials under the appropriate Code, and, to reject or revoke the signatory status of any company that is not a legitimate producer of Recorded Commercials.
